## **Application & Adjudication Procedures**

Each applicant may only submit one project, yet projects from different units/ groups of the same organisation are acceptable.

## 1. Initial Application (Deadline of Submission: 30 September 2020)

Complete this Project Submission Form and send to the CIFA Secretariat <u>on or before</u>

30 September 2020 together with a project synopsis of 500 words in English for initial screening. The synopsis should cover the following information:

- a) Project name
- b) Issues/Challenges to be addressed by the project
- c) Project objectives
- d) Project beneficiaries (current and/or potential)
- e) Brief project description
- f) Brief information on project achievements

## 2. Second Round Adjudication

A maximum of 16 entries will be short-listed from the initial applications for the Second Round Adjudication. Successful entries will be asked to present the Project in printed format with more details, at a maximum of 5,000 words in English which include the text, figures, tables and appendices. In addition to the basic information already submitted at the time of initial application, the followings have also to be included:

- a) Conceptual/Theoretical framework for the project
- b) Project methodologies and implementation
- c) Project partnership, if any
- d) Sustainability of the project and initiative
- e) Project replicability
- On top of the printed project description, audio-visual attachment of a maximum of 30 minutes may be appended.
- The Second Round Adjudication will be conducted on 18 and 19 March 2021 either in persons or through Skype in English to shortlist eight projects to enter the Final Round Adjudication.

#### 3. Final Round Adjudication

Among the eight finalists, teams from Taiwan and teams from outside Taiwan will be subsidised respectively at US\$200 per person, up to a maximum of US\$400 per team and US\$500 per person, up to a maximum of US\$1,000 per team, to attend the 6th CIFA Regional Symposium to be held in Taipei, Taiwan to present their projects at the Final Round Adjudication and the Award Presentation Ceremony on 10 June 2021.
